Please read ALL information and make sure everyone in your group is aware of these rules and regulations.

Lodge and Cabin area

Uinta County resident organizations:

Family and other non-youth - **\$560** per night

Youth groups (schools, churches, scouts etc.) - **\$415** per night

Non-resident organizations:

Family and other non-youth - **\$700** per night

Youth groups (schools, churches, scouts etc.) - **\$475** per night

Special Needs (VIP) Cabin: - **\$140** per night plus Lodge/Cabin fees

River Pavilion area

Uinta County resident:

Family and other non-youth - **\$240** per night

Youth groups (schools, churches, scouts etc.) - **\$225** per night

Non-resident organizations:

Family & other non-youth - **\$315** per night

Youth Group (Schools, Churches, Scouts, etx) - **\$300** per night

Yurt area

All organizations: - **\$100** per night

Commercial Rate:

All business entities

Lodge and Cabin Area: **\$800** per night

River Area: **\$400** per night.

Check in and out times:

Check in time is **2:00 pm** and check out time is **12:00pm (Noon)**. Any early arrivals or late departures will be charged an additional days use.

Reservations: Only applications for the Uinta County Youth Camp that are received in the Treasurer's Office by November 30th will be considered for initial scheduling of reservations for the upcoming year. Applications received without payment in full will NOT be considered for scheduling.

Scheduling priority for the Uinta County Youth Camp will be considered by the categories as follow:

- First: Uinta County 4H
- Second: Uinta County youth groups
- Third: Uinta County residents
- Fourth: Non-resident youth groups
- Fifth: Non-resident groups

Within each of the priority categories, all applications will be assigned a number as they are received and all numbers with duplicate date requests will be entered into a random generation for scheduling. Applicants that are claiming residency may be required to provide proof of residency. Questions may be asked and documentation may be requested for proof. Every effort will be made to meet the reservation requests submitted. If a cancellation is requested after initial dates of reservation are set, all fees collected will be forfeited unless the cancelled dates are in-turn reserved by another group to cover the dates and fees requested for refund.

Amenities: The Lodge/Cabin area can accommodate up to 140 people and has a lodge, kitchen and dining/recreation area with a large fireplace, shower house/restrooms and the warming hut off of a large open air patio with grill. There are 12 cabins with 6 single bunks per cabin (sleeps 12) play area, horseshoe pits, tether ball and a basketball standard.

River Pavilion area is for self-contained campers or trailers and tents. The pavilion is enclosed with a fireplace, dining/recreation area, a kitchen and shower house/restrooms.

The Yurt is about a mile away from the lodge/cabin area but is accessible by car or truck during summer months. It is a canvas structure on a deck and will sleep up to 8 people. It has an outhouse, fire ring, picnic table and cooking area with grill. There is no electricity or running water at the yurt but propane and some water are provided.

A Group representative shall check in with the caretaker upon arrival and be issued appropriate keys and a radio. A group representative must check out with the caretaker before leaving the camp.

Buildings and Grounds:

- Keys will be issued for each cabin used. Lost key fee is \$10 per key.
- Campers with dogs will be charged \$10 per day per dog. Dogs are not allowed in buildings and please clean up after them.
- A radio will be issued to contact the caretaker when needed.
- NO SMOKING in ANY building.
- If furnishings are moved around please return them to the original place.
- Beds and mattress are not to be removed from cabins.
- The speed limit on all camp roads is **20 mph**.
- Signs posted by Uinta County Camp Officials are not to be removed.

- All signs and decorations posted by renters in and out of buildings and on roadways up to the camp must be removed before leaving.
- Renters must clean the buildings and campgrounds to the same or better condition as found upon arrival.
- Thorough cleaning and mopping will be done in all buildings and inspected with caretaker during the check-out process.
- When the shower house or restroom's need to be accessed by the Caretaker a group must be present.
- Campers are responsible for emptying trash.
- A concrete pad is behind the kitchen area of the lodge, place all trash there and caretaker will haul it out.
- River campers need to bring trash to the pavilion for the caretaker to haul out.
- Warehouse and camp storage areas are off-limits to campers.
- Renters must protect all wildlife and their habitat.
- Cost of damages and/or clean up not done to the satisfaction of the caretaker will be billed to the campers.

Safety Rules:

- NO CONTROLLED SUBSTANCES WITHOUT A LEGAL PRESCRIPTION. Failure to comply shall forfeit future use of camping privileges for one (1) season.
- Fireworks are PROHIBITED.
- Be aware of where fire extinguishers are located and camp leaders are knowledgeable on how to operate them.
- No parking in emergency lanes or around buildings.
- Parking only in designated areas.
- Parking violators will be fined \$20 for each day they are in violation.
- Fires are allowed in designated areas and only if there is no County issued fire restrictions. There must be adult supervision around fires at all times.
- Firearms are to be used in the rifle range only and with a certified range master present at all times. A camp range master can be scheduled for shooting functions. Please schedule the camp range master and rifle range prior to arriving. Failure to comply shall forfeit future use of camping privileges for one (1) season.
- Law enforcement will be called if any individuals are drunk, disorderly, fighting or are in violation of local laws.

Activities:

- **Canoes:** SAFETY RULES MUST BE FOLLOWED. Canoes are for scheduled campers only and can be used at the fishing pond or taken to Meeks Cabin Dam. Campers will need to provide a vehicle with appropriate hitch for canoe trailer, caretakers will not tow canoes. Adult supervision is required at all times. A signed agreement from the caretaker

will need to be on file for any groups using the canoes. Please schedule canoes prior to arriving.

- **ATV's and off-road vehicles:** ATV's and motorbikes may be used at the camp but on improved roads only. No off road travel is permitted.
- **Fishing Pond:** The fishing pond is for scheduled campers only. Campers will need to pay at the pond kiosk five dollars (\$5) per camper per day to fish. No Wyoming Fish and Game license is required to fish at the pond but IS required for fishing in the Blacks Fork River. A fish transport receipt will need to be filled out by campers and caretaker if the pond fish are taken out of the Youth Camp property. There is also a fish food dispenser that takes quarters so campers can feed the fish.
- **Rifle Range:** Small caliber firearms and skeet shooting are allowed at the rifle range. A Certified range master must be present at all times and have proof of certification.
- **Playground:** Adult supervision is required at all times when children are playing on any playground equipment.

Miscellaneous:

- Please report any damage, breakage, malfunctions, emergencies or other maintenance concerns to the caretaker.
- Any damage or dog fees need to be paid in full to the caretaker before leaving the camp.
- The Uinta County Youth Camp is not responsible for lost or stolen items.
- Every camp must be properly chaperoned at all times.
- The Uinta County Youth Camp assumes no responsibility for accidents or health of campers.
- Please respect other camper's privacy and stay within your own campground.
- Please respect the wildlife and surrounding environment.

If you are found to be in violation of any of the above mentioned Rules and Regulations you may forfeit you or your group's ability to lease the Youth Camp in the future.
